This Third Registration Document Supplement has been approved by the Luxembourg Commission de Surveillance du Secteur Financier (the "CSSF") which is the Luxembourg competent authority for the purpose of Directive 2003/71/EC, as amended (the "Prospectus Directive") and relevant implementing measures in Luxembourg as a registration document supplement prepared in compliance with Article 16.1 of the Prospectus Directive and relevant implementing measures in Luxembourg.

Unless otherwise defined in this Third Registration Document Supplement, terms defined in the Registration Document (as supplemented by the First Registration Document Supplement and the Second Registration Document Supplement) shall have the same meaning when used in this Third Registration Document Supplement. To the extent that there is any inconsistency between any statement in, or incorporated by reference in, this Third Registration Document Supplement and any other statement in, or incorporated by reference in, the Registration Document (as supplemented by the First Registration Document Supplement and the Second Registration Document Supplement), the statements in this Third Registration Document Supplement will prevail.
